The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation.

ARTICLE ONE (Name) - The name of the corporation is MOBILE DOCKS, INC.
The principle place of business is: 128 S.W. Third Avenue, Dania Beach, FL 33004

ARTICLE TWO (Duration) - The date and time of commencement of corporate existence is concurrent with the time of filing Articles of Incorporation by the Department of State.

ARTICLE THREE (Purpose) - The purpose for which the corporation is organized, are to design, promote, cause to have built, rent, sell and market mobile loading docks to individuals, companies or organizations on a buy, sell, rent or charter basis, and to engage in any activity within the purpose for which corporations may be organized under the Florida General Corporation Act.
