The undersigned incorporator(s), for the purpose of forming a corporation under Florida Business Corporations Act, hereby adopt(s) the following Articles of Incorporation.

### ARTICLE I

The name of the Corporation shall be CCS Computers, Inc.

### ARTICLE II

Pursuant to section 607-0203, Florida Statutes, the effective date of this corporation shell be five (5) business days prior to the date of filling of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

### ARTICLE III

The principal place of business and mailing address of this corporation shall be: 408 Live Oaks Blvd, Casselberry, FL 32707

The Board of Directors may, from time to time, move the principal office to any other address in Florida. Branch offices may be maintained at such other places in the State of Florida, the United States of America, and foreign countries, as may be authorized by the Board of Directors.

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all things herein mentioned, as fully and to the same extent as natural person might do, viz:

To have perpetual succession by its corporate name.

 To sue and be sued, complain, and defend in its corporate name in all actions or proceedings.

- To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other matter, reproduced.
- To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise, deal in and with real or personal property or any interest therein, wherever situated.
- To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.

- To lend money to, and use its credit to assist its officers and employees in accordance with Florida Statute S607-141.
- To Purchase, take, receive, subscribe for or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestics or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or any other government, state, territory, governmental district or municipality or of any instrumentality thereof.
- To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises or income.
- To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so loaned or invested.
- To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state.
- To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.
