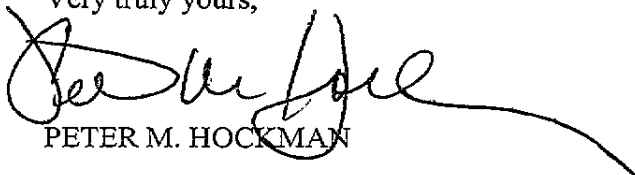

ARTICLE I - NAME

The name of this corporation is PINNACLE NACELLE, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

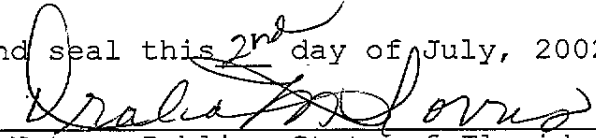

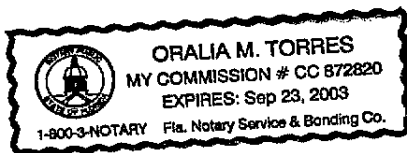

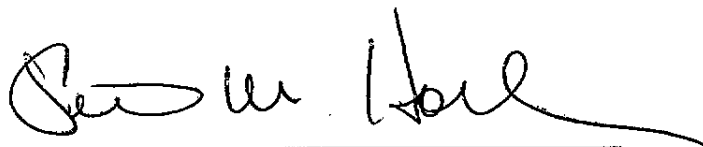
