**ARTICLE I**

The name of the corporation is The Dust Collector, Inc.

**ARTICLE II**

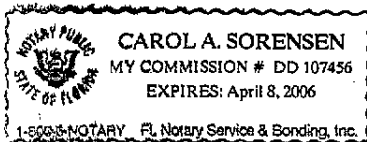
