## ARTICLES OF INCORPORATION FOR CAPTAIN JACK'S CEDAR RIVER, INQ2 JUL 10 PM 4: 46

In compliance with Chapter 607 and Chapter 621, Florida Statutes, the Incorporator, Jack Norton, hereby adopts the following Articles of Incorporation:

#### ARTICLE I: NAME

The name of the new corporation shall be Captain Jack's Cedar River, Inc.

#### ARTICLE II: PRINCIPAL OFFICE

The Principal Office of the new corporation shall be 243 South Edgewood Avenue, Jacksonville, Florida, 32254. The mailing address will be the same as the address of the Principal Office.
