Article I is hereby deleted and the following inserted in place thereof:

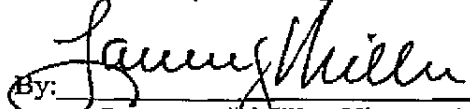
The name of this corporation shall be Mehr Mediation, Inc.
