ARTICLES OF INCORPORATION OF: BRUKSCH TECH INC.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

ARTICLE II - DURATION / TERM OF EXISTENCE

These articles of Incorporation may be amended in the manner provided by law. - 3. No shareholder of the Corporation may sell or transfer stock in this corporation except to another his

individual who is eligible to be a shareholder of the corporation.

ARTICLE IX POWER OF CORPORATION

The Corporation shall have the same powers as an Individual to do all things necessary or convenient to carry out its business affairs, subject to any limitations or restrictions imposed by applicable law or these Articles of Incorporation.

ARTICLE X INDEMNIFICATION

The corporation shall indemnify any office or director, to the full extent permitted by law.
