## ARTICLES OF INCORPORATION

#### **OF**

## **B & J ELECTRIC, INC.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of **B & J ELECTRIC**, **INC.**, does hereby set forth and declare:

## **CHARTER**

#### ARTICLE I

The name of the corporation shall be **B & J ELECTRIC**, **INC.**, Community of Bonita Springs, County of Lee, State of Florida.
