ARTICLE I - NAME:

The name of this corporation is **Abstracts of North Florida**, **Inc.**, (hereinafter referred to as the "Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing July 10, 2002, which is the date of subscription and acknowledgment of these Articles of Incorporation.
