# **ARTICLES OF INCORPORATION**

## **ARTICLE I** **CORPORATE NAME, PRINCIPAL OFFICE** **AND MAILING ADDRESS**

The name of this Corporation shall be: ***B & B MARINE, INC.***, with its principal office located at 2902 Sunset Drive, New Smyrna Beach, Florida 32168 and its corporate mailing address being the same.

## **ARTICLE II** **NATURE OF BUSINESS AND POWER**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

## **ARTICLE III** **CAPITAL STOCK**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of One Dollar (\$1.00) per share.
