Pursuant to written action of the Shareholders and the Board of Directors of the Corporation in lieu of a special meeting, the following resolutions were adopted on February 8, 2013, amending the Articles of Incorporation effective as of February 8, 2013:

RESOLVED, that Article One of the Articles of Incorporation filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:

**ARTICLE ONE
NAME OF CORPORATION**

The name of the corporation is Jerrold S. Parker, Inc. (the "Corporation"), and it shall be formed as a Florida corporation under Chapter 607, Florida Statutes.

RESOLVED, FURTHER, that Article Three of the Articles of Incorporation filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:

PURPOSE OF CORPORATION**

The purpose of the corporation is provide management services and to engage in any activity or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.
