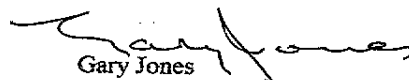

1. Name: The name of the corporation is: Stat Medical Technologies, Inc.
2. Purpose: The corporation may engage in any legal business.
3. Stock: The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 50,000 shares of common capital stock with no par value. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
