ARTICLE I. NAME

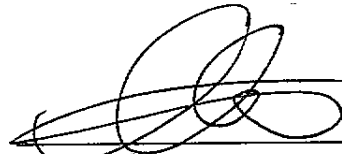
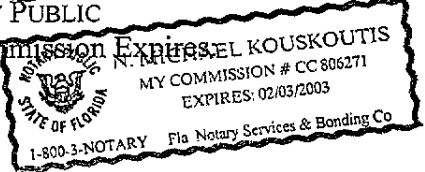

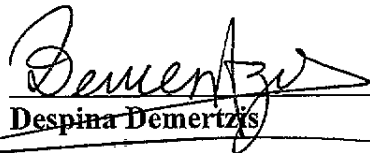
