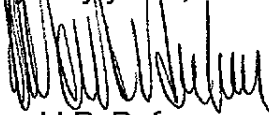

Article I - Name and Address

The name of this corporation **DOCKSIDE SEA GRILLE, INC.** with its principal address at 768 Northlake Boulevard, Lake Park, FL 33408.

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose and Powers

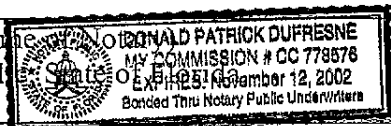
