The undersigned, acting as incorporator of DAW Financial, Inc. (the "Corporation"), pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the Corporation is:

DAW Financial, Inc.

ARTICLE II. ADDRESS

The mailing address of the Corporation is 4500 PGA Boulevard, Suite 200, Palm Beach Gardens, Florida 33418.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence at 12:01 A.M. on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The Corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 4500 PGA Boulevard, Suite 200, Palm Beach Gardens, Florida 33418, and the name of the Corporation's initial registered agent at that address is Douglas A. Walker.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The Corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.
