ARTICLES OF INCORPORATION LAWSON CUSTOM FRAMING, INC.

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of this corporation is LAWSON CUSTOM FRAMING, INC. and the principal place of business shall be 6259 Poss ARTICLE II.

DURATION: The corporation shall exist perpetually.

ARTICLE III
