

The undersigned, as incorporator, hereby executes these Articles of Incorporation for the purpose of becoming incorporated under Chapter 607 of the Florida Statutes, as amended, as a for-profit corporation under the laws of the State of Florida and certifies as follows:

**ARTICLE I.** The name of the corporation is Hospitality Recruiting Services, Inc. (the "Corporation").

**ARTICLE II.** The Corporation shall have a perpetual existence.

**ARTICLE III.** The Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be organized under the General Corporation Act of the State of Florida, whether granted by specific statutory authority or by construction of law.
