ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is Wellington Self Storage, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

ARTICLE III - BUSINESS AND PURPOSE
