The undersigned incorporator, for the purposes of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of this corporation is: TAMPA HEALTH CARE PROVIDERS, P.A. (the "Corporation").

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be:

ARTICLE III PURPOSE

The Corporation is organized for the sole and specific purpose of rendering professional medical services. The Corporation shall be authorized to transact any and all lawful business permitted by Chapter 621 of the Florida Statutes, the Professional Service Corporation and Limited Liability Company Act, as it exists on the date hereof or as hereafter amended.

ARTICLE IV CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having \$0.01 par value per share.
