2 JUL 12 PH 12: 56 The undersigned incorporator, a natural person competent to contact and Medical Doctor duly licensed to render services as such under the laws of the State of Florida, hereby forms a corporation for profit under the Professional Service Act and other laws of the State of Florida.

ARTICLE I - NAME AND PRINCIPAL OFFICE OF CORPORATION

The name of this corporation shall be Alberto Sirven, MD, P. A. The principal office and mailing address for this corporation shall be:

ARTICLE II-GENERAL NATURE OF BUSINESS

The general nature of business to be transacted by this shall be: The general practice of medicine, including but not limited to Obstetrics, Gynecology, Surgery, Infertility, Ureogynocology and the like.

To engage in every phase and aspect of the business of rendering the same A. professional services to the public that a medicine doctor duly licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees and agents of the corporation who are duly licensed under the laws of the State of Florida to practice medicine therein.
