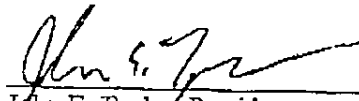

1. Pursuant to Florida Statutes Sections 607.1003 and 607.1006, Article One of the Articles of Incorporation of the above-referenced Corporation is hereby amended to change the name of this Corporation to JOHN E. TAYLOR, D.V.M., INC., and the old corporate name shall be replaced with the new name throughout the Articles of Incorporation of this Corporation.
2. Article Three is hereby amended to change the purpose or purposes of the Corporation to "Any and all business not prohibited by the Laws of the State of Florida."
3. The foregoing amendment was adopted as of November 13, 2018, by written unanimous consent of all of the Directors and Shareholders entitled to vote on the amendment, in accordance with Florida Statutes Sections 607.0704 and 607.0821.
