ARTICLES OF INCORPORATION

The undersigned Incorporator, being a person competent to contract, subscribes to these Articles of Incorporation to form a Corporation for profit under the laws of the state of Florida.

ARTICLE I - Name

The name of the corporation is Windows By Design, Inc.

ARTICLE II - Principal Office

The street address of the initial principal office of the corporation is 1130 E. Plant Street, Suite B, Winter Garden, FL 34787, and the mailing address of the corporation is 1130 E. Plant Street, Suite B, Winter Garden, FL 34787.

ARTICLE III - Capital Stock


