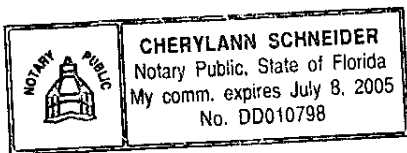
1. Shelly T. Gehle is a President of GOLD COAST SPRINKLER REPAIR, INC., a Florida corporation, (hereinafter "Corporation").
