**ARTICLES OF INCORPORATION
OF
DECORATIVE MARBLE CONSTRUCTION**

ARTICLE I – NAME

The name of this corporation is **DECORATIVE MARBLE CONSTRUCTION INC.**

ARTICLE II – DURATION

This corporation shall have perpetual existence unless dissolved according to law and its existence shall commence on the date of execution and acknowledgment.

ARTICLE III – PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV – CAPITAL STOCK

This corporation is authorized to issue TWO HUNDRED (200) shares of One Dollar (\$1.00) per value common stock, which shall be designed "common shares". Each of said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the incorporator, or by the Board of Directors, at a meeting called for such purpose.

ARTICLE V – PREENTIVE RIGHTS

Every stockholder, upon the sale of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof, as nearly as may be without issuance of fractional shares at the price at which it is offered to others.

ARTICLE VI – INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is: **19225 N.W. 53 CR PL, MIAMI, FLORIDA 33055**, but the Corporation shall have the power to move the principal office to any other address in the State of Florida, and to establish branch offices and other places of business within or without the State of Florida that may be deemed expedient, and the name of the initial Registered Agent of this Corporation is **OLVIN PONCE**.

ARTICLE VII – INITIAL BOARD OF DIRECTORS

This Corporation shall have 2 directors initially. The number of Directors may be either increased or diminished from time to time by the bylaws, but shall never be less than one (1).

Fifty-One percent (51%) of the shareholders entitle to vote, represented in person or by proxy, shall constitute a quorum at a meeting of shareholders.

If a quorum is present, the affirmative vote of 51% of the shares represented at the meeting and entitled to vote on the subject matter, shall be the act of the shareholders.

ARTICLE X - SHAREHOLDERS MEETING REQUIRED

Any action of the shareholders of this Corporation must be taken at a meeting of shareholders of this Corporation, dully called as provided by law.


ARTICLE XI - TERM OF DIRCTORS

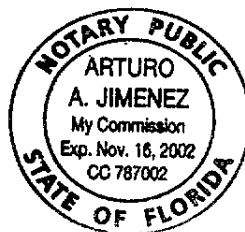




