ARTICLES OF INCORPORATION

OF

ALEX-ALLY CORP.

ARTICLE ONE

The name of the corporation is ALEX-ALLY CORP.

The principal address of the corporation is: 6431 Hudson Bay Lane, Lake Worth, Florida 33467.

The period of its duration is perpetual.
