Article I - Name and Address

The name of this corporation is:

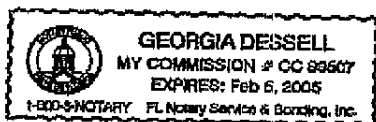

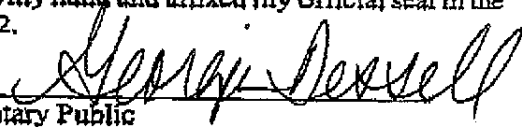
