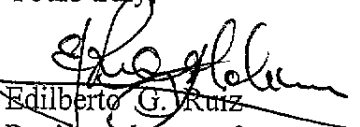

ARTICLE SEVEN – PURPOSE

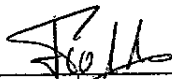
The purpose of the corporation is to engage in the business of providing consulting services in the fields of information technology, marketing and business administration to businesses and to the general public.

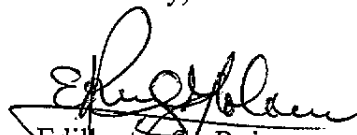
