AHASSEE, FLORIDA In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as the incorporator in adopting and filing the following

## ARTICLE I

The name of the corporation ("Corporation") is: Firehouse Coffee, Inc.

Articles of Incorporation for the purpose of organizing a business corporation.


