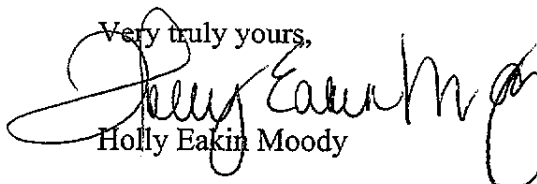

ARTICLE I

PETE'S COIN LAUNDRY III, INC.

The name of this corporation shall be PETE'S COIN LAUNDRY III, INC..

ARTICLE II

DURATION

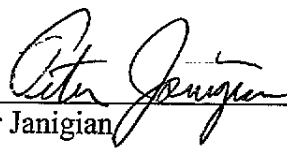
