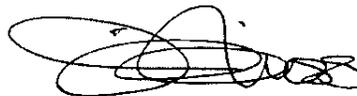

The name and address of the registered agent is: Varinia Van Ness, 46 North Washington Blvd., Suite 9, Sarasota, FL 34236.

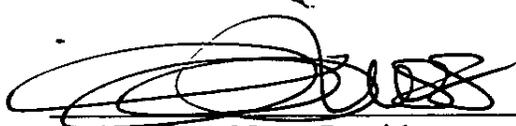
