ARTICLE 7 - CORPORATE CAPITALIZATION, is hereby amended as follows:

Section 7.1, 7.2 and 7.6 are hereby deleted and replaced as follows:

7.1 The total number of shares of all classes of stock which the Corporation shall have authority to issue is 10,000 shares, each having par value [\$0.01] per share ("Common Stock").

7.2 The Common Stock shall be divided into two classes. The first class shall consist of 100 shares designated as "Class A Common Stock". The second class shall consist of 9,900 shares designated as "Non-Voting Class B Common Stock."

The holders of Non-Voting Class B Common Stock shall not be entitled to vote on any matters submitted to a vote of stockholders of the Corporation.

7.6 The Board of Director(s) of the Corporation may, by amending its Articles of Incorporation, classify or reclassify any unissued stock from time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualification, or terms or conditions of redemption of the stock.


