ARTICLE I - NAME

The name of this corporation is Ramona Anderson, P.A.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This corporation is organized for the purpose of rendering specific professional service as attorneys.

ARTICLE IV - CAPITAL STOCK


