The undersigned, desiring to form a corporation under the provisions of the laws of the Stafe, of Florida, hereby make, subscribe and acknowledge before a notary public, and file with the Secretary of State of the State of Florida, the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is: SKY DAISY, INC.

- a. The general nature of the business to be conducted and carried on by the corporation is to provide yoga instruction to the public.
- b.
