## ARTICLES OF INCORPORATION

# ARTICLE I - NAME:

SECRETARY OF STATE TALLAHASSEE FLORIDA

The name of this corporation is: PRO TECH PAINTING, INC., hereinafter referred to as the "Corporation".

# ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

# ARTICLE III - PURPOSE:
