ARTICLES OF INCORPORATION
OF
TANGO B IMPORTS, INC.

ARTICLE I - NAME

The name of this corporation is TANGO B IMPORTS, INC. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE

The principal office of the Corporation is located at the following address:
