

ARTICLE ONE. NAME

The name of the corporation is E.F. RESTAURANT GROUP, INC.

ARTICLE TWO. PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

The corporation shall have all of the powers enumerated in the Florida General Corporation Act.
