The undersigned, for the purposes of forming a Corporation under Section 607.164 of the Florida General Corporation Act, do hereby certify as follows:

**Article I
Corporate Name and Address**

The name of the Corporation is **MUSIC BY DESIGN, INC.**, and the street address of the Corporation is:

**Article II
Corporate Purposes**

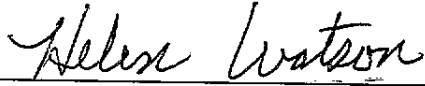
