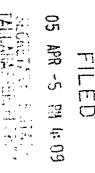

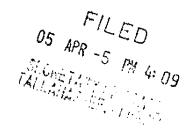

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SEA CAT BOATS, INC.

AMENDMENT

The Articles of Incorporation of Sea Cat Boats, Inc., a Florida corporation (the "Corporation"), are amended by revoking the current "Article IV – Capital Stock" and adopting the following in substitution thereof:

Article IV – Capital Stock: The total number of shares of capital stock which the Corporation shall have the authority to issue is 600 consisting of (a) 100 shares of voting Common Stock, par value \$0.01 per share, and (b) 500 shares of non-cumulative, non-voting Preferred Stock, par value \$1000.00 per share all of which shall be designated "Series A, non-cumulative, non-voting Preferred." The Series A, non-cumulative, non-voting Preferred shall have preference up to the stated par value, in liquidation of the Corporation and distribution of any Corporation assets to the Shareholders.

The remainder of the original articles of incorporation shall remain in full force and effect
