The undersigned, for the propose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is Smoke's Backyard Bar-Be-Cue Inc., (Hereinafter, "Corporation").
