The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is SEBRING COURT REPORTING, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal office is 6920 State Road 66, Sebring, Florida 33875

ARTICLE III: DURATION

The duration of the corporation is perpetual.

ARTICLE IV: PURPOSE

The general purpose of the corporation is the provision of court reporting services, labor, and sales and to engage in other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business; and engage in and transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE VIII: INITIAL BOARD OF DIRECTORS

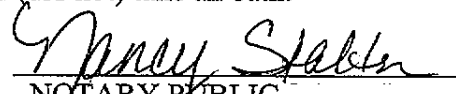

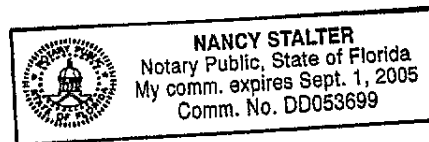

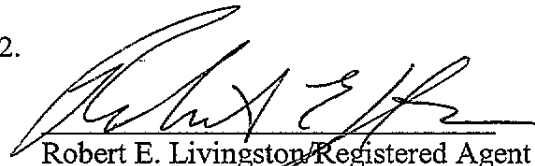
