ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is PARADISE HOME ENTERPRISES, INC., and the principal address and principal place of business is 941 CENTERWOOD DRIVE, TARPON SPRINGS, FLORIDA 34688.

ARTICLE II - REGISTERED OFFICE AND AGENT
