ARTICLES OF INCORPORATION

OF

KELLY YACHTS & CHARTERS, INC.

ON JULIO PHINE STS

ARTICLE I: NAME

The name of this corporation is KELLY YACHTS & CHARTERS, INC., whose address 241 El Vedado Road, Palm Beach, Florida 33480.

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE
