## ARTICLES OF INCORPORATION OF THE COMPUTER WHISPERER, INC.

ARTICLE I:

The name of this corporation is THE COMPUTER

WHISPERER, INC.

ARTICLE II: This corporation shall have perpetual existence.

This corporation is organized for the purpose ARTICLE III: of engaging in any activity or business permitted under the laws of the United States or the State of Florida.
