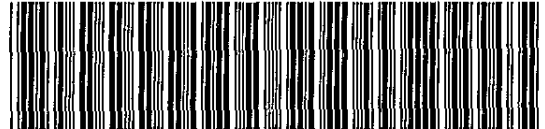

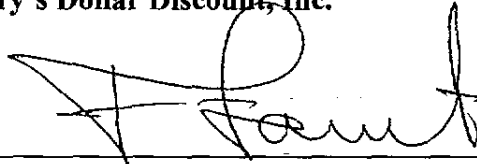
THIRD: The date of each amendment's adoption: **December 10, 2002.**

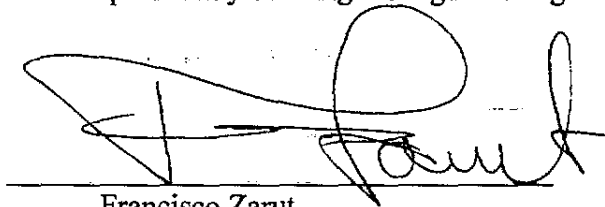
