**ARTICLES OF INCORPORATION
OF
DEMERE CONSTRUCTION, INC.**

ARTICLE I - NAME

The name of this corporation is DEMERE CONSTRUCTION, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.




