

ARTICLE I

Name. The name of this corporation is VBHB, Inc.

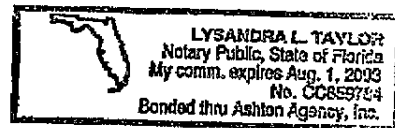
