ARTICLES OF INCORPORATION
OF
ARCADIAN, INC.

The undersigned incorporator, for the purpose of forming a non-profit corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation..

ARTICLE I. NAME.

The name of the non-profit corporation shall be Arcadian, Inc.

ARTICLE II. PRINCIPAL OFFICE & MAILING ADDRESS.


