## FIRST AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF CALLMINER, INC.

This First Amendment to Amended and Restated Articles of Incorporation of CallMiner, Inc. (the "Corporation"), a Florida corporation, were duly approved and adopted by the Corporation pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act by a written consent of the directors of the Corporation dated as of December 23, 2004 and a written consent of shareholders of the Corporation dated as of December 23, 2004, to be effective on filing with the Florida Department of State. The number of votes cast for the amendment by the shareholders as a single class and by the holders of Common Stock and Series A Preferred Stock, each as a separate class, was sufficient for approval.

FIRST: The Corporation's name is: CallMiner, Inc.

SECOND: The initial paragraph of Article Fourth, Section C of the Corporation's Amended and Restated Articles of Incorporation is deleted in its entirety and replaced with the following:

19,612,500 shares of the authorized Preferred Stock of the Corporation are designated "Series A Preferred Stock" with the following rights, preferences, powers, privileges and restrictions, qualifications and limitations.
