The name of the corporation shall be L.S. AUSTIN, INC.

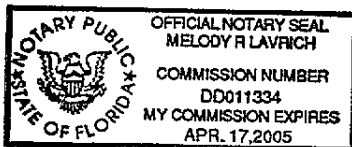
