The undersigned subscriber to these Articles of Incorporation, being a natural person, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I – NAME

The name of the corporation is Legal Services Investigator, Inc. (the "Corporation").

ARTICLE II – DURATION

This Corporation shall exist perpetually.

ARTICLE III – PURPOSE




